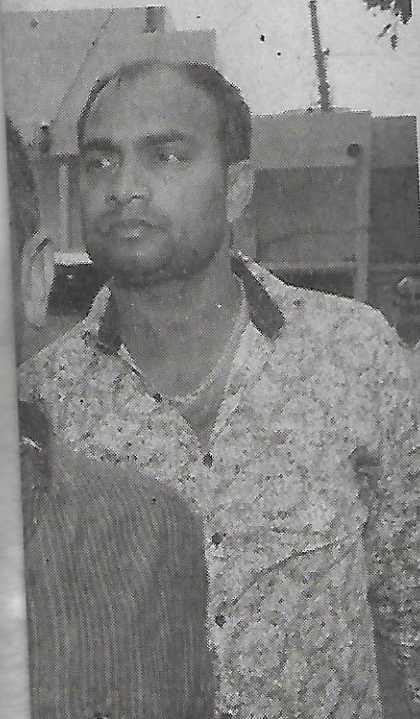

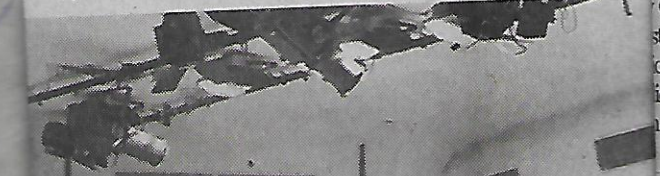

## 1 year jail under NDPS case

Chandigarh:  
Court of Additional District  
and Session Judge, Kuruk-  
shetra has sentenced a man  
to one year imprisonment  
along with fine of Rs 5,000  
under the Narcotic Drugs  
and Psychotropic Substances  
(NDPS) Act for possessing  
ganja.

The convict will have to  
undergo 15-days additional  
imprisonment in case of non-  
payment of fine.

Accused Ramesh Kumar  
of Indira Colony, Kuruk-  
shetra was arrested from  
near Ankur Nursing Home  
on the charging of possessing  
1 kg 800 gram of ganja on  
February 9, 2018. A case was  
registered against him in City  
Police Station, Thanesar.

After going through all the
